Deputy Speaker in the Chair

1. Communication of Message from Lt. governor

The Deputy Speaker read out the message dated 28.6.78 received by the Speaker from the Lt. Governor (Administrator) of Mizoram thanking the Members of the House for adopting the Motion of Thanks on his Address delivered to the House on the 22nd June, 1978.

2. Nominations to Committee

The Deputy Speaker announced the names of Members nominated to different Assembly Committees by the Speaker for a period of one year from 1st July, 1978.

3. Paper laid on the Table

Pu Lalhmingthanga, Minister i/c Revenue laid on the Table of the House-

Notification No. TDL/101/74-77/116 dated the 7th May, 1977 regarding Mizoram Trading by Non-Tribals (Regulation) Rules, 1977.

4. Private Members' Resolutions

Private Members' Resolutions were taken up in accordance with the balloted list circulated under para 17 of Bulletin Part II Dated 24th June, 1978.
