March, 1973 with Statements of Objects and Reasons are published under Rule 71 of the Rules of Procedure and Conduct of Business in the Mizoram Legislative Assembly, for general information.

THE CONTINGENCY FUND OF THE UNION TERRITORY OF MIZORAM (DETERMINATION OF AMOUNT) BILL, 1973.

Α

BILL

to determine the amount of the Contingency Fund of Mizoram.

Be it enacted by the Legislative Assembly of Mizoram in the Twenty Fourth Year of the Republic of India as follows:—

Short title:

1. This Act may be called the Contingency Fund of Mizoram (Determination of Amount) Act, 1973.

Determination of Amount.

2. There shall be paid into the Contingency Fund of Mizoram a sum of Rupees ten lakhs from and out of the Consolidated Fund of Mizoram.

STATEMENT OF OBJECTS AND REASONS:

In Section 48 of the Government of Union Territories Act, 1963, Provision has been made for establishment of a Contingency Fund in the nature of imprest for the Union Territory. This Bill therefore seeks to establish the Contingency Fund of the Union Territory of Mizoram.

Hence the Bill.

THE APPROPRIATION (NO.1) BILL 1973

Α

BILL

to provide for the withdrawal of certain further sums from and out of the Consolidated Fund of Mizoram to the services for the period from 3rd May, 1972 to 31st March, 1973.

Be it enacted by the Legislative Assembly of Mizoram in the twenty fourth year of the Republic of India as follows:-

- 1. This Act may be called the Appropriation (No.1) Short title Act, 1973.
- 2. From and out of the Consolidated Fund of the Union Territory of Mizoram there may be paid and applied sums not exceeding those specified in column 3 of the schedule amounting to the sum of rupees two crores fiftyfour lakhs sixtythree thousand seven hundred and eighty only towards defraying the several charges which will come in course of payment during the financial year 1972-73 (3.5.72 to 31.3.73) in respect of the service specified in column 2 of the schedule.

Issue of Rs2,55,26,780. 00 out of the Consolidated Fund of the Union Territory of Mizoram for the Financial year 1972-73 (3.5.72 to 31.3.73)

3. The sums authorised to be paid and applied from Appropriation and out of the Consolidated Fund of the Union Territory of Mizoram by the Act shall be appropriated for the services and purposes expressed in the schedule in relation to the period from 3.5. 72 to 31.3.73.

STATEMENT OF OBJECTS AND REASONS

In pursuance of the recommendation of the Lieutenant Governor (Administrator) of the Union Territory of Mizoram this Bill is introduced to provide for the appropriation out of the Consolidated Fund of the Union Territory of Mizoram of the moneys required to meet the expenditure charged on the Consolidated Fund and the Additional grants voted by the Legislative Assembly, Mizoram for expenditure of this Union Territory for the period from 3. 5. 1972 to 31. 3. 1973.
