The rates of compensation for trees, plants, crops etc. At the fixed by the Committee. All compensation is directly related to market value of property and market prices of commodities situated in urban towns and agricultural profine in exporting centres or within easy access of lines of commo leations. The rail head and major roads and markets cannot be put at par with properties situated elsewhere. It may not be equitable or even practicable to its one rate for the whole of Mizoram. The factors that have to be taken into second. In Fixing compensations may be already detailed in some rules either in 2.W.D. order or the Land Revenue Rules. These rules if any may be consolted.

When fixing compensation for trees, etc. etc. the annex; (conse from finit-bearing trees may also be considered.)

In case of compensation for land, trees, Gardens, Plantan, as, Buildings and vehicles etc. etc. the Department concerned will best know to procedure to the followed in fixing, assessing the rates.
