**“The Mizoram Appropriation (Demand for Grants 2021-22) Act, 2021”  
(Act No. 5 of 2021)**

**(Received the assent of the Governor of Mizoram on 23.3.2021)**

AN  
ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services of the Financial Year 2021-22.

It is enacted by the Legislative Assembly of Mizoram in the Seventy Two Year of the Republic of India as follows:-

Short Title

1. This Act may be called the Mizoram Appropriation (Demand for Grants 2021-22) Act, 2021.

Issue of **Rs. 1133088.78 lakh**  
out of the Consolidated Fund  
of the State of Mizoram for the  
Financial Year, 2021-2022.

2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of Rupees eleven thousand three hundred thirty crore eighty eight lakh seventy eight thousand only for defraying the several charges which will come in course of payment for the Financial Year 2021-2022 in respect of the services specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.

Repeal &amp; Saving

4. The Mizoram Appropriation (Demand for Grants 2020-21) Act, 2020. (Act No.1 of 2020) published in the Mizoram Gazette Extraordinary Issue No. 186 of dt.31.3.2020 is stand hereby repealed.
